DISCUSSION ITEMS:

A list of ordinances the Planning Commission is currently working on was passed out to Council for review. The question was asked if Council should start reviewing ordinances also. It was decided Council is going to review the ordinance concerning how many people a rental is allowed based on the number of bedrooms. This will be put on the March Workshop agenda for discussion

The vacancies on the Park Board and the Zoning Hearing Board were discussed. These will be moved to the February Council meeting for action.

The agreement with the Presbyterian Senior Housing will expire December 31, 2019. This agreement allows them to make a payment in lieu of taxes to the Borough, School District and County. It was decided the agreement will be given to Solicitor Black to renegotiate.

President Karl stated he and the Borough Administrator had been working on a cost to present to Slippery Rock Township for allowing our police to respond to incidents in the township before the State Police would arrive. The majority of Council is in favor of working out another agreement with them. This will be ongoing discussion.

Council reviewed the 2019 Capital Fund Expenditures and would like more information on a few items:

- 1) What is the generator currently hooked up to?
- 2) List of what the generator needs to be hooked up to?
- 3) Keep looking for agreements for the retaining walls for the solicitor to review
- 4) Police Chief to search for grants for body and car cameras

These will be discussed at a future meeting.

ADJOURNMENT:

A motion was made by Royce Lorentz to adjourn. Seconded by Gene Allison, motion carried.
